JUDGMENT AND SENTENCE

IN THIS MATTER, the defendant, Carl B. Tilley, appeared before this Court on June 24, 1996, for a Change of Plea Hearing. The defendant was accompanied by his attorney, Mr. Robert Carroll. The State was present and represented by Gregory S. Corpening, County and Prosecuting Attorney, in and for Lincoln County, Wyoming. The defendant was fully advised of the charges filed against him, to wit, three (3) counts of Fraud by Check, in violation of Section 6-3-702(a)(b)(i) W.S.(1988), the maximum penalty for the offenses, and his Constitutional rights, all of which the defendant indicated that he understood.

Next, the defendant pled nolo contendere to three (3) Counts of Fraud by Check, in violation of Section 6-3-702(a)(b)(i) W.S.(1988). The defendant was competent to enter a plea; and the plea was voluntary, and not the result of force or

1 The Court thereupon inquired of the defendant if he knew of any reason why
2 sentence should not be pronounced at this time and no good or sufficient reason
3 having been given, and the Court being fully advised in the premises;

4 NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED, as
5 follows:
6

7 1. That the defendant is hereby sentenced to the Lincoln County Jail,
8 Kemmerer, Wyoming, for a period of six (6) months on each count, to run
9 consecutively, for a net period of incarceration of eighteen (18) months, provided,
10 however, that all of the aforesaid sentence is hereby suspended.

11 2. That the defendant is hereby placed on unsupervised probation for a period
12 of six (6) months for each count, to run consecutively, for a net period of probation
13 of eighteen (18) months, subject to the following terms and conditions:
14

15 a) That the defendant pay a fine in the amount of \$750.00, for
16 each count for a total fine of \$2,250.00, provided, however, that
all of the aforesaid fine is hereby suspended.

17 b) That the defendant pay \$50.00 for each count to the Wyoming
18 Crime Victims Compensation Fund, for a total of \$150.00.

19 c) That the defendant shall pay restitution in the amount of
20 \$989.10 to Interstate Battery System of Rock Springs.
21 Judgment is hereby entered against the defendant on behalf of
Interstate Battery in said amount and shall bear interest at the
22 statutory rate.

23 d) That the defendant shall pay restitution in the amount of
24 \$2,875.97 to Photocomm, Inc. Judgment is hereby entered
against the defendant on behalf of Photocomm, Inc., in said
amount and shall bear interest at the statutory rate.

25 e) That the defendant shall reimburse the Office of the State Public
26 Defender in the amount of \$190.00.

- h) That the defendant shall not issue any insufficient funds or bad checks.
- i) That the defendant not be arrested for nor convicted of any bad check or fraud related offenses, high misdemeanors or felonies and in all other ways shall be a law abiding citizen.

IT IS FURTHER ORDERED that Counts III and V of the above entitled matter, to wit, Check Fraud, in violation of §6-3-702 (a)(b)(iii) W.S. (1988), are hereby dismissed without prejudice.
