
NOTICE OF LIEN LIS PENDENS

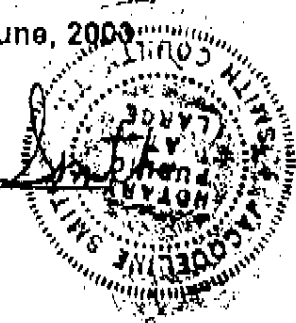
